

1. World Trade Organization (WTO)

Purpose: The WTO aims to facilitate smooth and fair international trade by creating and enforcing trade agreements, resolving disputes, and providing a forum for trade negotiations.

Countries Participating: 164 member countries, including major economies like the United States, China, and the European Union.

Key Highlights:

- Promotes trade liberalization and reduction of trade barriers.

2. European Union (EU)

5. Organization of the Petroleum Exporting Countries (OPEC)

Purpose: OPEC coordinates and unifies petroleum policies among member countries to ensure stable oil markets and fair prices for producers. Countries Participating: 13 oil-producing countries, including Saudi Arabia, Iran, and Venezuela.

Key Highlights:

- Regulates oil production to manage supply and influence global oil prices.
- Promotes cooperation among member countries on oil-related policies.
- Engages in dialogue with major oil-consuming countries and international organizations.
